## Allegheny Conference announces leadership transition

Morgan K. O'Brien to serve as chair of Conference in 2014

Richard J. Harshman named Conference vice chair and new chair of Greater Pittsburgh Chamber of Commerce

(PITTSBURGH – November 6, 2013) – In advance of its Annual Meeting this evening, the Allegheny Conference on Community Development is announcing leadership changes as current Allegheny Conference Chair Charles E. Bunch, chairman and CEO of PPG Industries, completes his term of service.

While we have made progress, we have much work to do. I look forward to working with private, non-profit and public sector partners to advance our people and our communities in today's global economy," said O'Brien.

Richard J. Harshman, chairman, president and CEO of Allegheny Technologies Incorporated, who currently serves on the Allegheny Conference board and Executive Committee, will succeed O'Brien as chair of the Greater Pittsburgh Chamber of Commerce

board, effective January 1, 2014. Harshman will also join Conference Vice Chairs Laura E. Ellsworth, partner-in-charge of Jones Day - Pittsburgh and chair of the Pennsylvania Economy League of Greater Pittsburgh and David J. Malone, President and CEO of Gateway Financial and chair of the Pittsburgh Regional Alliance as a vice chair of the Conference.
