### **New Valerus Aftermarket Facility Opens in Southwestern Pennsylvania**

**[Houston, Texas, November, 2nd 2011]** – Valerus today announced the opening of a two-story, 21,500 square foot aftermarket service facility in Smithfield, Pa. (Fayette County). The newly constructed facility will primarily serve energy companies working in the region, providing them with a wide range of aftermarket field application and repair services for their oil and natural gas handling equipment.

“By supplying fast, reliable around-the-clock field-and-shop services, the Smithfield facility will help customers minimize unscheduled work stoppages and breakdowns while reducing their operating costs,” said Daniel B. Cannon, Valerus Sr. Vice President, North America.

“The facility is fully equipped and provides a complete range of mechanical services, preventive maintenance and operations packages, and machinist services. It will also carry a large inventory of spare and replacement parts for both standard and custom original equipment manufacturers,” added Cannon.

Staffed with dedicated original equipment manufacturer (OEM)-certified and continually trained technicians, the Smithfield facility and its team of professionals can quickly diagnose problems, deliver and install custom parts, or refurbish or overhaul existing equipment – all within tight OEM tolerances.

Currently the facility has 14 employees, and plans call for adding 10 to 12 additional positions over the next year with competitive compensation and benefits.

Special care went into choosing Smithfield as the location for the new facility, which is centrally situated in both the Utica and Marcellus plays and thus near Valerus customers.

“The Fay-Penn Economic Development Council and the Pittsburgh Regional Alliance were especially helpful to Valerus with their collaborative efforts to bring the Smithfield location to our attention and their work to facilitate the opening of the facility, which will bring high-quality jobs to the region”, said Valerus Regional Vice President, Chris Scheve.
